POSTDOCTORAL SCHOLARSHIP SELECTION PROCESS IN THE PROGRAM POSTGRADUATE COURSE IN SCIENCE TEACHING AT UFRPE

The Coordination of the Postgraduate Program in Science Teaching, of the Federal Rural University of Pernambuco, hereinafter referred to as PPGEC/UFRPE, in the exercise of its attributions, establishes norms and

selection procedures for Postdoctoral Fellows, related to the POSTGRADUATE DEVELOPMENT PROGRAM (PDPG) – STRATEGIC PARTNERSHIPS IN THE STATES III, 38/2022.

1 Objectives and target audience

1.1 This announcement aims to select a Post-Doctoral fellow, for a period of 12 months, to work at PPGEC/UFRPE, according to their lines of research, having as supervisor a professor of the Program. The fellow

will work on research activities related to their work/research plan, and must also engage in other academic activities of the PPGEC/UFRPE, according to the guidelines of their supervising professor and/or the Program coordination.

1.2 Holders of a Doctorate degree obtained in courses evaluated by CAPES and recognized by CNE/MEC, in areas of knowledge related to the major area of Education, with a specific focus on Teaching Science and Mathematics, are eligible to apply for this selection process.

2 Prerequisites and responsibilities

2.1. The candidate for the Post-Doctoral fellowship must meet the requirements basics listed below:

- Be a doctor;
- Not be retired or be in a similar situation;
- Not to be part of the functional structure of the Federal Rural University of Pernambuco;
- Do not accumulate scholarships from any federal, state or municipal funding agency.

- Fit in and have expertise in the area of Science and Mathematics Teaching.



2.2 The candidate must have an updated CV on the Lattes Platform – CNPq, dated April 2025;

2.3 The value of the scholarship is R\$4,100.00 (four thousand and one hundred reais) per month and the scholarship holder must work 40 (forty) hours per week;

2.4 The scholarship holder cannot be in default with any funding agency. until the date of implementation of the scholarship, this being a condition of automatic disqualification of the candidate;

2.5 The scholarship holder may not receive another scholarship (regardless of the funding body), nor have an employment relationship;

2.6 The scholarship holder must be available to reside, throughout the duration of the scholarship, in the metropolitan region of the city of Recife, Pernambuco, aiming at active participation in research with his/her supervisor's group and in the activities of PPGEC/UFRPE.

3 Of the inscriptions

3.1 Registrations will be made exclusively by email posdoc.ppgec@gmail.com ; subject "Registration for Post-Doc PPGEC/UFRPE".

3.2 To register, Brazilian candidates must fill in all the requested information and attach the following documents in *portable document file* (PDF) format:

- a) Registration form duly completed (Annex I of this notice);
- b) Declaration of availability of working hours (Annex II of this notice);
- c) Copy of identity document and CPF;
- d) Copy of the Doctorate Diploma or declaration proving the title has been obtained;

e) Copy of the Thesis;

- f) Lattes CV (updated until April 2024);
- g) Summary report and activity plan (Annex III of this notice).

3.3 Foreign candidates without a permanent residence visa in Brazil must attach and send all requested information and attach the following documents in *portable document file* (PDF) format:

a) Registration form duly completed (Annex I of this notice);

c) Copy of the Passport page containing the document number, photo and identification of the candidate;

d) Copy of the Doctorate Diploma or declaration proving the title has been obtained;

e) Copy of the Thesis;

f) Lattes CV or Vital CV with link to ORCID (updated in April 2024);

g) Summary report and activity plan (Annex III of this notice);

h) Proof of proficiency in Portuguese, with at least intermediate level, or other equivalent certification;

3.4 The absence of any of the above documents will result in the disqualification of the candidate;

3.5. Documents will not be submitted after the end of the registration period.

5 Judging and ranking candidates

5.1 The selection of candidates, whose applications are approved, will be evaluated by an Examining Board, made up of members of the faculty of the PPGEC/UFRPE.

5.2 The selection process will consist of the following steps:

a) Document analysis (eliminatory);

b) Memorial and Activity Plan;

c) Analysis of the CV, using the criteria indicated in the application analysis form (annex IV of this notice).



5.3 Each member of the committee will assign a score from 0.0 (zero) to 10.0 (ten) for the sum of the scores of the stages referred to in item 5.2.

5.4 Candidates who have not completed their training stages (master's and/or doctorate) at UFRPE will have their final grade increased by 10%, in order to minimize the possibility of endogenous activity.

6 Final classification

6.1 The final classification of candidates will be obtained by the arithmetic mean of the examination board's grades;

6.2 Candidates who obtain a final grade lower than 7.0 (seven) will be disqualified.

6.3 In the event of a tie, the following tie-breaking criteria will be used, successively:

- I. highest score in the curriculum analysis;
- II. highest grade in the activity plan;
- III. age, with preference given to the oldest candidate.

7 Final provisions

7.1 It is the sole responsibility of the candidate to monitor the acts concerning this selection process, which will be published on the website. PPGEC/UFRPE.

7.2 At any time, this Notice may be changed, revoked or annulled, in whole or in part, in accordance with the relevant legislation, whether by unilateral decision of the Examining Board established for such purposes, or for reasons of public interest or legal requirement, without this implying the right to compensation or claim of any nature;

7.3 Omitted cases will be decided by the Examining Board.
